### OPEN CALL Solidary City – the consent to the processing of personal data (please mark the relevant box)

1.  Acting on my own behalf, I consent to the processing of my personal data by the Association of Polish Architects Wrocław Branch (hereinafter referred to as SARP O/Wrocław), 50-123 Wrocław, ul. Oławska 21/5-6, for the purposes of OPEN CALL competition "Solidary City" organised as part of the 10th edition of the DoFA Lower Silesian Architecture Festival 2022, in order to carry out the full Open Call procedure, and in particular to communicate with each other and make the results public (both in SARP O/Wrocław's own media and in partner media - the press, websites, etc.), to organise the exhibition, possibly to publish the submitted works in the DoFA '22 catalogue, as well as for documentation and archiving purposes, in accordance with the Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 (GDPR).

2.  I have been advised that:

- 1) my personal data will be processed by SARP O/Wrocław in order to carry out the full Open Call procedure, for the purpose of its documentation and archiving, in particular for the purpose of communicating with Participants, as well as making the results public;
- 2) the controller of my personal data is SARP O/Wrocław. These data will be processed at the controller's seat in Wrocław(50-123), ul. Oławska 21/5-6;
- 3) I have the right to access my personal data and the right to correct or rectify them, as well as the right to lodge a complaint with a supervisory authority or to object to improper processing of my personal data;
- 4) I have the right to request the erasure, transfer of data or restriction of their processing or the right to withdraw my consent at any time without affecting the lawfulness of the processing carried out on the basis of the consent before its withdrawal, in accordance with the provisions of the Regulation of the European Parliament and of the Council (EU) 2016/679 of 27 April 2016 (GDPR), with the reservation that the request to cease the processing of personal data to the extent necessary to participate in the competition (and therefore the data required in the Application Form) means resignation from participation in it.
- 5) the consent given with regard to the scope of processing indicated in point 1 may be withdrawn at any time, however the withdrawal of the consent does not affect the lawfulness of the processing carried out on the basis of the consent before its withdrawal. In the event of withdrawal of the consent, the controller may process data only to the extent and for the period justified by the purpose of processing resulting from the provisions of generally applicable law, including to protect its legitimate interests.
